## 1 Marine Safety

SZC Harbour Authority is committed to meeting the requirements of the Port Marine Safety Code (PMSC). To meet these requirements the SZC Harbour Authority has developed policies and plans covering the code as well as a Marine Safety Management System (MSMS) based on Formal Risk Assessment.

The SZC has appointed a Duty Holder who is accountable for compliance with the code and its performance regarding marine safety. The Duty Holder for SZC Harbour Authority is the Harbour Board. The Duty Holder recognises that the accountability for marine safety cannot be delegated.

The SZC Harbour Authority has appointed an appropriately qualified individual as the Designated Person to provide assurance to the Duty Holder that the MSMS is effective. The Designated Person has direct access to the Duty Holder.

To meet the requirement of the PMSC, the SZC Harbour Authority is committed to:

- Maintaining an effective MSMS based on the elements identified through Formal Risk Assessment which is reviewed on a timely basis.
- Publishing on a three yearly basis a Marine Safety Management Plan which will be regularly reviewed and updated to ensure continuous improvement.
- Manage vessel traffic in the SZC Harbour Authority jurisdiction to a level determined through Formal Risk Assessment.
- Provide an appropriate level of pilotage services in accordance with the 1987 Pilotage Act .
- Conserve the Port for vessel traffic through hydrographic survey and, where required, dredging.
- Ensure the provision of appropriate aids to navigation.
- Enforce the regulations and legislation applicable to the port.
- Provide appropriate resource to ensure the safety of marine operations.
