## 1 Competence & Training Standards

This policy should be read in conjunction with Sizewell C Training policy.

SZC Ltd will assess, using the most appropriate means available, the competence of all persons appointed to positions with responsibility for safety of navigation, and provide additional training where such a need is identified.

The Duty Holder will ensure that individual Board members receive an introduction to their duties under the PMSC. All Board members will subsequently receive PMSC refresher training at intervals not exceeding three years.

Wherever practicable, the SZC Harbour Authority will engage and consult with port users to develop a shared understanding of the marine safety management system in use.

The following Marine SMS components are the fundamental elements which control and manage competence and training at SZC and will be maintained and updated by the Harbour Master:

- Marine Training Matrix
- Marine Training log

Adequate records will be maintained for the qualification, training and experience of Sizewell C personal and embedded contractors to demonstrate individual and organizational competency.
